

# **Annual Report 2023**

**Forward**: Housing Initiatives, Inc. (HII) is an organization incorporated 1992 in the State of Wisconsin as a non-profit, tax-exempt organization under section 501(c)3 of the Federal Internal Revenue Code. For the past 30 years, the organization has consistently operated with the objective of providing permanent supportive housing to people who have experienced homelessness and who also live with severe mental illness. In addition to the provision and maintenance of housing, the organization also provides supportive services to assist clients in maintaining their housing and thriving in various aspects of life despite their mental health challenges and other concerns.

**Mission Statement:** Housing Initiatives, Inc. exists to provide permanent housing for persons in Dane County who have a severe and persistent mental illness and are experiencing homelessness because of the illness.

#### Who We Are

Housing Initiatives is a proven leader in providing homes, hope, and recovery to people who have become homeless due to mental illness and other setbacks. In the past 30 years, the organization has provided stable housing options and support to over 1,000 people.

### **How We Help**

- Creation of affordable, permanent housing Housing Initiatives purchases and renovates smaller, multi-unit properties to provide residential-setting housing for clients. HII owns or manages 33 properties throughout the City of Madison, representing 151 units and currently housing 222 people.
- Housing Stabilization Housing Initiatives screens people into its program, not out. Following a Housing First philosophy, the organization intentionally provides housing to individuals who frequently face many barriers to housing. This is done with the understanding that until someone is housed, it is often impossible to move on and address other challenges they may be facing.
- Supportive Services Housing Initiatives employes four FTE case workers to build supportive relationships with clients, and to then build support networks around them to fully address whatever impediments they may face to stable housing and continued success.
- End Veteran Homelessness Housing Initiatives partners directly with the Veterans Administration to provide housing opportunities to homeless veterans. This is a targeted and intentional dimension of our housing and supportive services programs.


